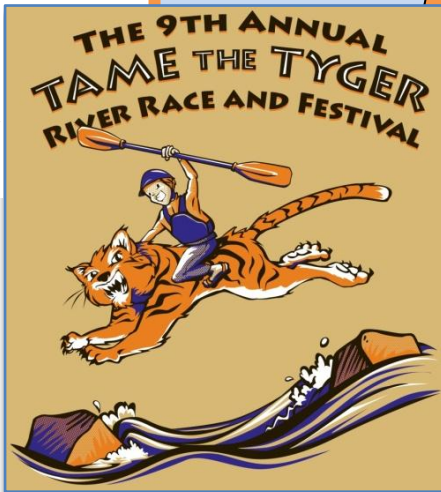

DIRECTIONS

To race start from I-85 in Spartanburg, SC:
Take I-26 E toward Columbia. Take Exit 28 at Hwy. 221 and turn right. At the 2nd stoplight turn left onto Hobbysville Road. Turn left onto Morris Bridge Road. The put-in is just beyond the bridge at the river.

To race start from the Columbia area, travelling I-26 W:

Travelling west on I-26 toward Spartanburg, take Exit 35. Turn left onto S.J. Workman Highway. Take a right onto Price House Road, then right onto Hobbysville Road, and then left onto Morris Bridge Road.

To race finish:

If you are travelling I-26 E take Exit 35 and turn left onto Walnut Grove Road. If you are travelling I-26 W take Exit 35 and turn right onto Walnut Grove Rd.

From Walnut Grove Road turn right onto Shaw Road and follow to stop sign. Turn left onto Old Hills Bridge Road. The race finish is at the Campground on the right, just beyond the bridge.

To race finish from race start:

Take Morris Bridge Road back to Hobbysville Road, stay right. Turn left onto Price House Road. At stop sign turn left onto S.J. Workman Highway and cross over I-26. Go about 1/2 mile, turn right onto Shaw Road and follow to stop sign. Turn left onto Old Hills Bridge Road. Cross bridge and park in open space at the campground.

RELEASE WAIVER AND INDEMNITY OF CLAIMS AND LIABILITY

This **release** is executed this ____ day of _____, 2008, by the registrant whose name and address is printed above (hereinafter "registrant"). In consideration of being permitted to participate in the "Tame the Tyger River Race and Float," organized by Spartanburg County Parks and Recreation (hereinafter "County"), registrant hereby **releases, waives and discharges** County, its officers, employees, members, promoters, sponsors, and advertisers from all liability to the registrant, his/her spouse, legal representatives, heirs and assigns, for any and all loss or damage, and any claim or damages resulting there from, on account of injury to registrant's person or property, even injury resulting in death of the registrant, whether caused by the negligence of County, others released herein, or otherwise while the registrant is in any way participating in the events surrounding the "Tame the Tyger River Race and Float."

Registrant agrees to **indemnify** the County, its officers, employees, members, promoters, sponsors, and advertisers from any loss, liability, damage or cost they may incur due to the presence of registrant in or upon the Tyger River, its banks, bridges, or access roads, whether caused by the negligence of the County or otherwise.

Registrant hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of County or otherwise while in or upon the Tyger River, its banks, bridges, or access roads, and while competing, officiating in, working or for any purpose participating in the "Tame the Tyger River Race and Float."

Registrant expressly agrees that this **release, waiver, and indemnity** agreement is intended to be as broad and inclusive as permitted by the Laws of the State of South Carolina and that if any portion thereof is held invalid, it is agreed that the remaining portion shall continue in full legal force and effect.
